

## WHAT DOES KINGSTON10 EXCHANGE, LIMITED DO WITH YOUR PERSONAL INFORMATION?

### **Why?**

Financial Companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

### **What?**

The types of personal information we collect and share depend on the product or service you have with us. This information is identified with specificity in our Privacy Policy, and can include:

- Account profile information such as name, phone number, email and physical addresses
- Social Security number
- Assets, income, and employment information
- Investment experience and risk tolerance
- Consumer account balances and payment history
- Transaction information related to purchases and sales of cryptocurrency

### **How?**

All financial companies need to share customers' personal information to run their everyday business. In the below, we list the reasons financial companies can share their customers' personal information, the reasons Kingston10 Exchange chooses to share, and whether you can limit this sharing.

Reasons we can share your personal information?

#### **For our everyday business purposes**

**Yes.** So we may process your transactions, maintain your account(s), respond to court orders and legal investigations, or report to or obtain information from credit bureaus.

#### **For our marketing purposes**

**Yes.** We share so as to offer our products and services to you.

For joint marketing with other non-Kingston10 Exchange, Limited financial companies

we do not share any information for this purpose.

#### **For our affiliates' everyday business purposes**

**Yes.** We share information about your transactions and experiences.

#### **For our affiliates' everyday business purposes**

**Yes.** We share information about your creditworthiness.

#### **For our affiliates to market to you**

**Yes.** We share information for this purpose.

For our NON-affiliates to market to you

NO. We do not share information for this purpose.

Yes. However, you may only limit our sharing with our affiliates to market to you.

### **Limit Our Sharing**

If you wish to limit our sharing of your information, you may choose one of a few different options to instruct us to stop sharing information where possible:

*\*Notice to new customer:* We can begin sharing your information 30 days from the date of this notice. When you are no longer our customer, we continue to share your information as described herein. To limit sharing, contact us at any time, share your request and we will process it immediately. Generally, if your information has been shared, you should start to see results 30 days or more after your request.

## **What We Do?**

How does Kingston10 Exchange, Limited protect my personal information?

- To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.

How does Kingston10 Exchange, Limited collect my personal information?

- We collect your personal information, for example: when you, o Open an account or deposit money o Use your credit or debit card or make deposits or withdrawals from your account o Give us your contact information or tell us who receives the money
- We also collect your personal information from others, such as our affiliates or other companies.

Why can't I limit all sharing? ● Federal law gives you the right to limit only:

- o Sharing for affiliates' everyday business purposes—information about your creditworthiness
- o Affiliates from using your information to market to you
- o Sharing for non-affiliates to market to you

- State laws and individual companies may give you additional rights to stop sharing.

## **Definitions**

### **Affiliates**

Typically, they are companies that are related by common ownership or control and are either financial and non-financial entities.

### **Non-affiliates**

Typically, they are companies that NOT related by common ownership or control. They can either be financial and non-financial entities.

### **Joint marketing**

Typically, the relationship consists of a formal agreement between the two or more non-affiliated financial or non-financial entities that, together, market financial or other products or services to you.
